	(b) Violation of	any rules or regulati	ons adopted by the Board of

(c) Commission of an act or conduct inimical to the interest and purposes of the Club." (underscoring provided)

'Section 8.4 NOMINATION. The Election Committee shall, thirty (30) calendar days prior to a scheduled election, nominate the Regular Members who are candidates for Governors. In addition, the Committee shall simultaneously call for and accept nominations in writing from Regular Members; provided, however, that the members of the Election Committee shall be disqualified from being nominated or elected. The period for nomination shall be closed twenty (20) <u>business</u> days prior to the scheduled election. The official list of nominees shall be prepared by the Committee and posted at the Clubhouse bulletin board at least fifteen (15) calendar days prior to the date of the meeting at which the election shall be held. Such list shall likewise be attached to the Notice of Meeting to be sent to all members.

The procedure for nomination of Independent Governors shall be in accordance with Rule 38 of the Implementing Rules and Regulations of the Securities Regulation Code or any amendments thereto.' " (underscoring provided)

7) Election of the nominees of management as members of the Board of Governors, including Independent Governors for 2023 - 2024:
